

TRITON FANTASY TERMS AND CONDITIONS

These Terms and Conditions (“TNC”) govern your use of the Triton Fantasy feature (“TF”) within the Triton Poker Plus mobile application (the “App”).

Any use of the words “you”, “your” or similar expressions shall mean any user of the Triton Poker Plus mobile application (the “App”) and the Triton Fantasy feature within the App (“TF”). Terms such as “we”, “us”, “our”, refers to SENS TECHNOLOGY CO. LTD., a company incorporated in 85, Fenlex House, St. John Street, Valletta VLT 1165, Malta.

ACCEPTANCE OF TERMS

Please read these TF TNC carefully as they set out the terms that apply to your use of the Triton Fantasy (“TF”). By using the TF, you confirm that you accept these TF TNC and agree to comply with them. If you do not agree to these TF TNC, you must not use the TF.

PARTICIPATION IN THE TF

You must be of legal age 21 (or higher legal age required in your jurisdiction), to register for an account and participate in the TF.

You are solely responsible for ensuring that your participation in the TF is legal in your applicable jurisdiction. By participating, you warrant that it is lawful for you to take part in the TF.

OTHER APPLICABLE TERMS

These TF TNC shall be in addition to the App's main [Terms and Conditions](#) and the main [Privacy Policy](#), and the [TF Rules](#), which shall all apply to the TF, as if the same were set out in full herein, and any conflict between them, these TF TNC shall apply.

NATURE OF TF

The TF is designed to provide users with personal entertainment and is free to play.

The App does not provide facilities for:

- Placing real money bets;
- Depositing or withdrawing funds;
- Participating in any real-money gambling activities.

TF (GENERAL DESCRIPTION)

Participation in TF:

- Does not require any payment, entry fee, or purchase;
- Involves user interaction, including the selection of players;
- Relies on objective performance data derived from live poker tournaments;

FREE-TO-PLAY MODEL

TF is operated on a strictly free-to-play basis.

Users are not required to:

- Make any payment to use the TF;
- Purchase tokens, credits, or virtual items;
- Engage in any financial transaction to participate or improve their performance. poker tournaments;

The TF does not require or allow any:

- Paid entry to play the TF;
- Purchasable gameplay advantages.
- Monetized progression systems tied to gameplay outcomes.

PRIZES AND RECOGNITION

From time to time, we may offer prizes for participation in the TF.

Prizes and Recognition:

- We may provide discretionary prizes or recognition elements to enhance user engagement.
- The prizes are non-transferable and cannot be exchanged for cash.
- Triton may modify, substitute, or withdraw prizes at its discretion.
- Prizes if any shall be announced and published before the commencement of any TF event.
- In some cases, we may be unable to deliver prizes to certain locations due to logistical or legal restrictions
- Winners are responsible for any customs duties, import taxes, or local charges i We are not responsible for shipping delays, losses, or delivery issues beyond our control
- Winners must ensure that receiving a prize complies with their local laws event.
- For prizes involving travel or live event experiences, winners are responsible for holding valid travel documents (passport, visa, etc.) required to attend
- Travel and accommodation dates, where applicable, are fixed by us and are non-negotiable
- Where travel costs are included in a prize, winners must pay for the tickets upfront and provide proof of payment. Triton will reimburse the approved amount in USDT.
- Prizes cover the winner only; companions are not included unless explicitly stated
- Any component of a prize (e.g. hospitality access, meet and greets) is subject to availability and may be altered or withdrawn for reasons outside our control
- Winners must meet the age of 21 and above to receive a prize, at the time when winners are announced.
- If a winner is unable or subsequently discovered to be ineligible to claim a prize, we may, at our sole and absolute discretion, forfeit the prize without any replacement winner or forfeit the prize and award the prize to another participant.
- By accepting a prize, winners consent to the use of their name, image, and likeness for promotional purposes, unless prohibited by local law
- Individuals directly employed, contracted or engaged by Triton or its affiliated companies to provide any services to Triton and/or its affiliated companies are not eligible to claim any prize.

For the avoidance of doubt, Apple is not a sponsor, promoter, partner of, or in any way affiliated or otherwise associated with TF. Apple does not provide, fund, administer or support any prizes, rewards, benefits or digital recognition offered in connection with TF.

SPONSOR CONTENT

The TF may display branding, content, or promotional materials from third-party sponsors.

Such sponsor involvement is limited to branding and promotional visibility.

Participation in TF:

- Is not conditional on engagement with any sponsor;
- Does not require registration with third-party platforms;
- Does not involve any external financial activity.

ACCESS TO TF

We aim to ensure that TF is available at all times. However, we do not guarantee that the TF or any part of it will always be available or uninterrupted.

The TF is provided on an “as available” basis and access to the TF may be affected by:

- Technical issues;
- Maintenance;
- Updates or system changes.

NO RELIANCE ON INFORMATION

The content provided in TF, which includes data based on live poker tournaments, is for general information purposes only.

While reasonable care is taken, we do not guarantee the accuracy, completeness, or timeliness of such data. The data may be subject to delay, revision, or correction.

You acknowledge that reliance on such data is at your own risk.

INTELLECTUAL PROPERTY RIGHTS

The TF and all content within it, including text, graphics, data, gameplay mechanics, and branding, are protected by intellectual property rights owned by us or licensed to us.

All such rights are reserved.

You may use TF for personal and non-commercial purposes only.

You must not:

- Reproduce, distribute, or modify content;
- Create derivative works;
- Use our branding or Triton’s branding without permission.

YOUR LAWFUL USE OF TF

You must use the App in a lawful manner and must not:

- Attempt to gain unauthorized access to our systems or data;
- Introduce malicious software or harmful material;
- Use automated tools or bots;
- Engage in conduct that disrupts or undermines the integrity of the TF.

EXTERNAL LINKS

The TF may include links to third-party services.

We do not control or endorse such services and are not responsible for:

- Their content;
- Their availability;
- Any loss arising from your use of their services.

VIRUSES AND SECURITY

While reasonable steps are taken to secure the TF, we do not guarantee that it will be free from viruses or harmful components.

You are responsible for ensuring appropriate security measures, including the use of anti-virus software, on your own device.

LIMITATION OF LIABILITY

To the fullest extent permitted by law, we shall not be liable for:

- Any indirect or consequential loss;
- Any loss arising from use of the TF;
- Any reliance on information or gameplay outcomes;
- Any interruption or unavailability of the TF.

Nothing in these TNC excludes liability that cannot be excluded by law.

CHANGES TO THESE TF TNC

We may amend these TF TNC from time to time, with immediate effect upon posting of the changes to this App.

You are responsible for checking these TF TNC regularly to ensure that you are aware of and understand the changes that have been made.

Your continued participation in the TF shall constitute acceptance of such changes. If you do not agree to the changes, you should not continue participating in the TF.
